# PLEDGE OF ALLEGIANCE TO THE FLAG

Paul Chatfield presented a summary of the status of various projects that Chatfield Engineers, P.C. is completing.

Bergen Highway Garage over the past month each of the contractors has been working on punch list items. Contracts A (General Construction) Building Innovation Group has completed their contract requirements and punch list items with a total payment due of \$69,286.25. Contract B (Plumbing) Thurston Brothers still have to take care of punch list items \$12,940.00 is being held until all items are completed. Contract D (HVAC) Pipitone Enterprises has completed their contract requirements and punch list items their final payment due is \$3,956.00. Contract D (Electrical) Northeastern Electric have completed on site punch list items, awaiting closeout paperwork and are holding a \$4,447.50 payment until all items are completed.

Peachey Road Water District; CE #05-678: As a follow up to the June 21, 207 informational meeting Chatfield engineers will be proceeding with preparation of the Boundary map and description and preliminary engineering report. Mr. Chatfield plans on presenting the information at the August 14, 2007 board meeting, after which a public hearing can be held in early September. The board discussed sending a follow up letter that would be sent to district residents for those that decided to opt -out.

Water District #4; CE05-678: Mr. Chatfield will be scheduling a meeting with Anne Sapienza in July to review the project area and identify the properties to be served in each alternative area. The additional areas will be tabulated and alternative cost estimates will be prepared. Once he gets this information he will review options and alternatives with the Town Board.

**Bergen Sewer Expansion**: Representatives from the Village of Bergen presented a sewer expansion; the Village system has reached capacity. More capacity is needed in the Town of Bergen for economic development growth for Apple Tree Acres Corporate Park. The Village is upgrading existing system and plans to double capacity from 104,000 gpd to 208,000 gpd with a \$2 million capital project with possible future inter-municipal expansion. The expansion can't disproportionately burden village residents it must be shared across constituency/benefactors (village, school district and town/county). New York Municipal Law allows GCEDC to re-direct new tax revenues generated from economic development projects (pilot payment) for public purposes, Pilot Increment Financing (PIF). The Village is asking for \$14,256 over 10 years which will be generated new economic development projects such as Ad Tech Graphics and Pavilion Gift. A motion was made by Councilman Miller to approve the re-allocation or pilot funds for AD Tech Graphics and Pavilion Gift expansion to assist the Village in offsetting the costs of upgrading their sewer plant, contingent upon satisfactory an agreement between the Town and Village on an updated gallon per day allowance for the Apple Tree Acres Industrial Park, it was seconded by Councilman Cunningham it carried by a *cote of 4-0.* 

<u>Legislator Charles Zambito</u> asked if the board had any questions for him since he was there for the sewer presentation. The board updated him on the 2 water districts that are proposed. The board asked him if he could talk to Tim Hens about the Snow & Ice contract with the county; the formula that is used should be more reasonable compared to other areas.

Gary Fink expressed concerns with the Peachy Road and North Lake Rd. water district and the burden on the people that don't want the water; with the cost they will incur. Gary also recommended an increased tapping fee with added revenue going to directly against the project cost & lower debt service charges for those not connecting.

MINUTES: Councilman Cunningham made a motion to approve the minutes of June 12; Councilwoman Baker seconded it carried by a vote 4-0.

# **COMMUNICATIONS:**

Proposal update from HSBC

NYS request for audit of Justice Court – Supervisor Specht will place an ad for proposals for an independent audit. The board also agreed to resume department audits in January 2008.

Road Striping info from Superintendent Roggow Councilwoman Baker made a motion for Superintendent Roggow to continue road striping on area roads as usual, it was seconded by Councilman Cunningham it carried by a vote 4-0.

<u>HIGHWAY</u>: Superintendent Roggow discussed the work on Robins Brook Park; they have moved the fence and brought in millings for parking area east of transfer station. He also asked for permission to mow around Bergen Welcome signs. *Councilman Cunningham made a motion that the Town Board authorizes the Highway Superintendent to permit the use of Town Highway equipment & personnel to mow weeds along the State Rights of Way at the Bergen Welcome signs in area; as time allows, it was seconded by Councilwoman Baker, it carried by a vote 4-0.* 

UNION CONTRACT: Negotiations were discussed.

#### **OLD BUSINESS**:

Estimate to modify public access to Town Clerk's office. Councilman Miller approved the estimate of \$1200 by Gary Fink to modify Town Clerk's office door, it was seconded by Councilman Cunningham it carried by a vote 4-0.

#### **NEW BUSINESS:**

Law suit against the Town of Bergen Highway Department for an accident on Rt. 490 and the Rt. 33 Bridge. Deputy Highway Superintendent Chad Roggow said it was actually a Village of Bergen Highway truck involved in the accident. Paperwork is being forwarded to Town Attorney and Insurance Carrier.
