WHEREAS the Town Clerk is the custodian of Town records and the Town's records management officer, Now, therefor, be it RESOLVED

RESOLVED, that the Town Clerk is hereby designated as records access officer in accordance with the provisions of the Freedom of Information Law and the regulations promulgated by the Committee on Open Government.

SEQRA RESOLUTION #15-2010 FOR LOCAL LAW #1-2010

Councilman Nenni made a motion for Supervisor Cunningham to sign the SEQRA impact assessment form; seconded by Councilman McCartney and it carried by a vote 4-0. Councilman Nenni presented the following resolution# 15-2010 and moved that it be adopted; seconded by Councilman Miller and it carried by a vote 4-0.

Town of Bergen Resolution # 16-2010

WHEREAS, on July 13, 2010, the Town Board of the Town of Bergen, New York shall consider a Local Law to provide for the codification of certain Local Laws, Ordinances, and Resolutions of the Town of Bergen into a Municipal Code (the "Local Law"); and

WHEREAS, the Town Board of the Town of Bergen ("Board") is principally responsible for undertaking, funding or approving the foregoing Local Law and its anticipated impact is primarily of local significance; and

WHEREAS, to aid the Board in determining whether such Project and financing and other actions of the Board in connection therewith (the "action") may have a significant effect on the environment, the board has caused to be prepared an environmental assessment form or similar information ("EAF"), a copy of which is attached hereto; and

WHEREAS, the Board has duly reviewed the EAF and duly considered the impacts which may be expected to result from the proposed action with the criteria set forth in the State Environmental Quality Review Act and the applicable regulations promulgated thereunder ("SEQRA"); and

WHEREAS, the Board had determined that the Project is an Type II Action pursuant to SEQRA; and

NOW THEREFORE, BE IT RESOLVED BY THE TOWN BOARD OF THE TOWN OF BERGEN, BERGEN, NEW YORK AS FOLLOWS:

- 1. The Board hereby declares itself and is hereby designated as Lead Agency for the proposed action and therefore responsible for determining whether an environmental impact statement is required in connection therewith and otherwise complying with the procedural and substantive requirements of SEQRA.
- 2. Based upon the review by the Board of the EAF and other necessary criteria, the Board hereby finds and determines that the proposed action is "Type II" under SEQRA and will result in no significant impacts and therefore, such action is not one which "may include the potential for at least one significant adverse environmental impact," (b) "there will be no significant adverse environmental impacts," and (c) no "environmental impact statement" need be prepared, as such quoted terms are defined in SEQRA and no further review of the actions need be taken pursuant to SEQRA.
- 3. A copy of this resolution shall be placed on file in the office of the Town Clerk where the same shall be available for public inspection during business hours and such notice of negative declaration shall be filed in such offices, posted in such places and published in such manner as shall be necessary to conform to the requirements of SEQRA.

This resolution shall take effect immediately

Adoption of Local Law #1-2010 Councilman McCartney made a motion to adopt Local Law #1-2010 as the Town Code; seconded by Councilman Nenni and it carried by a vote 4-0.

<u>Appoint Additional of Dog Enumerator</u> Councilman McCartney made a motion to appoint Connie Kaufman as an additional Dog Enumerator; seconded by Councilman Nenni and it carried by a vote 4 -0.
