## RESOLUTION #18-2012 2013 BUDGET CORRECTION

WHEREAS, the Town of Board of the Town of Bergen has adopted a budget for year 2013, and

**WHEREAS**, the Town of Bergen 2013 Budget does include a summary of charges related to the Peachey Road Water District, and

**WHEREAS**, the summary of charges related to the Peachey Road Water District does outline 95 EDU's at a rate of \$536.00, and **19 vacant lots** at a rate of \$25.00 per lot, and 2 conditional exemptions at a rate of \$25.00 per lot for a combined total to be raised in the amount of \$51,445.00, and

WHEREAS, after the adoption of the 2013 budget, an error was discovered in the number of vacant lots, and

WHEREAS, the correct summary of charges related to the Peachey Road Water District are as follows:

95 EDU's at a rate of \$536.00 per 17 Vacant Lots at a rate \$25.00 per 2 Conditional Exemptions at a rate of \$25.00 per Total to be raised = \$51,395.00

**NOW, THEREFORE BE IT RESOLVED,** that the Board of the Town of Bergen recognizes the correction to the summary of charges related to the Peachey Road Water District,

**AND BE IT FURTHER RESOLVED,** that a revised 2013 Bergen Town Budget summary detail shall be provided to the Bergen Town Clerk to record this correction.
