Town News ... From the Desk of Town Supervisor *Donald Cunningham*

The Town Board has adopted the 2018 budget and has several projects planned for the coming year. The budget includes a slight rise in the tax rate to \$2.2381 per thousand after 3 consecutive years at \$2.2198 per thousand. With other revenue sources on a decline the increase was inevitable to cover rising costs, maintain services, and fund planned projects. The Fire District saw a more significant rise of approximately \$0.10 per thousand due primarily to adjusted rates for Workers Compensation Insurance. The budget covers the traditional equipment, operational, and service needs of the town and holds appropriations for projects to further enhance community sites and upgrade facilities for accessibility and efficiency. To that end, the board has approved a project outline submitted by the Genesee Valley Educational Partnership (G.V.E.P.) Conservation & Heavy Equipment Class to begin improvements at Drews Nature Center, and further work is being identified for both the Library Building and Historians Office. Plans are also in motion for the Robins Brook Park project. All should be shaping up and progressing in the coming year.

A Turning Over of the Reins...

As I write this article and prepare to hand over the Supervisors office to Ernest Haywood at the end of the year, I reflect on my 16 years of service on the town board with many fond memories. Several projects have been completed over the years through careful planning to minimize the tax impact on residents. Renewing the roof on the Harford Barn & Livery, revitalizing the exterior and improving the roof design of the Library building, completing new facilities for the town hall, court, and highway garage, moving the Historians office & museum for greater accessibility, and developing a variety of high quality recreation fields to support our youth programs are but just a few. Public water was extended north of the village and down Peachey Road, the Comprehensive Plan has been renewed, and commercial development continues to grow. As I contemplate many other projects completed, the ones planned, and the efforts put forth by this, and boards past, it seems more staggering than stagnant.

Through it all I've been honored by the service of the town employees and fellow elected officials who were devoted to common goals and whom I had the pleasure of serving with. To them I owe a great deal of thanks in supporting the projects and processes of town business with a conservative approach to minimize the impact on town tax payers while being persistent year after year to address areas in need of improvement or change. I'm very confident that this trend will continue under the leadership of Ernie Haywood. Ernie brings strong experience from his former roles as Village Trustee and School Board President. He is also well connected with state officials and familiar with state programs through his professional career and will bring his knowledge and experience to the benefit of Bergen. Congratulations to Anne Sapienza and James Starowitz on election success as they join the board with new perspectives and fresh ideas. As Supervisor I've been very fortunate to always have a good back up in my Deputy; Brian Stone, Joe Nenni, and Barry Miller were always at the ready and there when needed. I was comfortable and confident knowing that the town was in good hands in my absence. As a native and long time resident of Bergen, I am most honored by having had the opportunity to serve the community I love in this capacity and my appreciation goes to all who supported me in this experience.

From the Desk of County Legislator *Robert Bausch*

I would like to begin by thanking the voters in Legislature District 2 for their support on Election Day. It was gratifying that a significant number of residents took the time to vote. So again, thank you.

When the County Legislature reorganizes in January, there will be three new legislators. District 1 (Towns of Alabama and Oakfield) has been represented by Ray Cianfrini for the past 10 years. Ray has also served as legislative chairman for the past four years. He did not seek reelection. John Hilchey, former Highway Superintendent for the Town of Oakfield and currently a sales representative for roadway materials will be the new legislator from District 1. In District 3 (Towns of Pembroke and Darien) the current legislator, Mike Davis also did not seek reelection. Gordy Dibble will be the new legislator from District 3. Gordy is currently the Chief Deputy, Road Patrol in the Sheriff Department. Finally, in District 9 (west end of the City of Batavia) long time legislator Ed DeJaneiro was defeated by former Sheriff Gary Maha. With these changes, one third of the legislators will be new in January.

The new legislature will be facing some significant issues. The most pressing will be water. The county is in the process of increasing the water supply from the Monroe County Water Agency (MCWA). In addition to the actual construction, an updated water agreement with MCWA will be required. Also, the agreements with the City of Batavia, towns and villages require updating (18 different agreements).

In mid-January, the legislature is scheduled to receive its initial report on the status and need for a jail. This has been, and will continue to be, a very slow and deliberate process. Genesee County is not immune to the opioid crisis. Although the options available to the county are limited, it must be prepared to take the necessary actions when required. County residents must recognize that this epidemic is impacting the county government as well as the personal toll in loss lives and family tragedies.

A little good news: The 2018 county budget was passed without a property tax increase. After some quarters of flat, and in some cases negative growth in sales tax revenue, it is at least remaining flat and hopefully will grow slightly in 2018.

In closing, I would like to wish everyone Merry Christmas and Happy New Year and look forward to serving District 2 residents in the coming year.

Mary Utley Wightman early resident of 12 Rochester St., my current home. Wanda MacVean, former Bergen Town Historian, found a series of letters between Mary Wightman to her daughter, May. Wanda typed them out and handed copies to me shortly before her death in 1997. The letters led me to be inquisitive about the people who had lived in the house before my family occupied it.

The house was built in about 1850 and I believe Mary and her two children were the first residents of it. Mary was a widow. She never spoke of her husband in the letters I received from Wanda. He died in 1857 in Herkimer County, New York. He was a Baptist minister. The copied letters were dated 1864 and 1865. I believe Mary and her family moved into Bergen shortly after her husband's death. Why they chose Bergen, I do not know. Mary had 2 children May Elizabeth born in 1848, and Jay Cuttler in 1854. Jay died in 1873 of typhoid fever at the age of 19 in Westfield, NY. The daughter died in 1927 at the age of 77, also in Westfield, from angina pectoris. Mary died in 1924 at the age of 104 years, 8 months. All 3 are buried in Westfield, NY. I have visited the grave sites.

I believe Mary left Bergen in or around 1870 and moved to Westfield. This move was made to be closer to her daughter who was teaching in the Westfield schools and Chautauqua area. The letters were written to her daughter and were full of family news, sickness, and village happenings. Most happenings were related to church meetings, conversions, and all. The greetings which Mary used in the letters were "My Dear Little Girl", and "My Dear Child".

My house was also owned by Mrs. E.V. Green, then Willard and Lillian Munger. He was a mail carrier. My grandparents on my father's side, Erotus and Mary MacConnell later owned the home. My parents took it over after his father died and his mother was unable to stoke the coal fire. They moved in about 1946 just before my birth. Mary died soon after, and my mother's mother, Martha Wilcox, joined us until her death in early 1958. I was devastated upon her death because she spent so much time listening to my stories from school. Grandma Wilcox was my everything! I will continue to live in the home, until it is no longer possible.

Please be reminded that during a “normal” snow event, it will take plow trucks 2 ½ to 3 hours to complete one pass on all roads. As such, it is very possible that everyone will encounter less than pleasant driving conditions at times. Late evenings and early mornings, with very light traffic volumes, will receive lower levels of service. Every attempt will be made to maintain open and passable roadways, both for normal and emergency traffic. At times, lanes may narrow and accumulate snow. The Town is responsible for snow and ice removal on all Town and County roadways in Bergen as well as State routes. This winter, as in the past, we will strive to provide the same level of the safest possible roadways at all times, within reason and budget constraints.

Also remember to use caution on snow covered roads. Here are a few safety tips: Slow Down, Make safe lane changes, pump your brakes on slick roads, and lastly don't tailgate, especially the plow truck. If you can't see him in his side mirror there is a good chance he can't see you! And for on First Aid rule: Carbon Monoxide is called “the silent Killer” if you go off the road keep your exhaust clear of snow.

Two additional reminders: Mailboxes, if damaged by our plows will be repaired or replaced, within Town Board adopted limits, as soon as weather, time permits. PLEASE, when installing or repairing your mailbox, remember that our trucks require a minimum 17 ½ feet from center of the roadway. Also, take into account the excessive force of the exhausted snow as it strikes your mailbox assembly.

Please don't hesitate to call me at 494-1362 if I may be of service. Highway Department hours are 7:00 am – 3:30 pm Monday thru Friday. However, you may leave a message 24 hours a day on our answering machine, and I will return your call as soon as possible. In closing, the entire highway department would like to wish everyone a healthy and happy holiday season, and a safe winter.

Town & County Taxes

If you pay your own taxes, you will receive your tax bill shortly after January 1, 2018. If you should receive a tax bill that an escrow company or someone else is supposed to pay, please call me right away. Don't put it aside and assume that it will be paid. Also, if you have paid off your mortgage and did not receive a tax bill, you should call me. No matter what the situation is, you are responsible for your taxes and penalties, if it is not paid. If you are leaving town for the winter please leave your "winter" address with me so late fees can be avoided. Credit cards (Visa, MasterCard, Discover and American Express) are accepted for payment with a convenience fee.

Tax payments cannot be received before January 1, 2018 per the County Treasurers office, all payments will be stamped after that date. Taxes are due penalty free by January 31st, all taxes have to be paid to me by March 31st. After **March 31st**, the unpaid taxes are returned to the County Treasurer. If you are going to pay them to the County Treasurer by mail, you will need to call his office in Batavia at 344-2550, ext. 2211 as there will be additional penalties.



Dog License News:

I hate to "hound" you, but if your dog's license renewal is due or past due, please take care of it so we don't have to send you a reminder notice or eventually a court appearance ticket. All dogs, four months of age need to be licensed even those in apartments. Proof of a rabies vaccination and proof of neutering or spaying must be presented at the time of licensing. If you receive an appearance ticket, you will have to pay a fee of \$25.00 plus also pay for your dog's renewal. If there is a problem getting an appointment for a rabies vaccination, etc., please call me. I have an answering machine so you can call anytime day or night.
