TOWN NEWS ... FROM THE DESK OF TOWN SUPERVISOR Ernest Haywood

The Bergen Town Board adopted the 2021 Budget on October 27 cutting spending by \$179,189. Those savings were overshadowed by estimated reductions of \$240,000 in revenue from Genesee County and \$16,775 in state aid. The net result is a tax levy increase of \$12,497 (exclusive of fire and water districts).

In other parts of the budget, the Fire District tax levy was reduced by \$6,295; the tax rate will remain the same for Water District No. 2; and the Peachey Road Water District rate will drop by about \$50 per full EDU. Residents of the new water district will see their first water district tax. It will be \$322 in 2021 and will increase to the expected \$550 in 2022.

A ribbon cutting for the completion of the renovations to the library and town offices at 13 South Lake Street occurred on September 26th. As in person attendance was limited do to COVID-19 restrictions, the event was live streamed on face book. Senator Michael Ranzenhofer, Assemblymen Steven Hawley as well as representatives from the Town, Village, Library and the NIOGA library system joined me in the ribbon cutting ceremony.

Work on the new water district continues. During the first week of November, the highway department dug more than 40 test pits. Soil samples were taken and sent to a lab for testing. We secured permission from CSX for crossing under the railroad and we are working on collecting easements from property owners. The COVID-19 Pandemic has slowed the approval process, but we expect to be out to bid early in 2021 with the entire project complete in 2022.

We are all weary of the Pandemic but we must try to remain vigilant during the coming months when we will be spending more time indoors and in closer proximity to others. Locally COVID numbers are rising. Please remember to wear a mask when in public, sanitize your hands frequently and avoid large gatherings. New York State has enacted heavy fines for those host large gatherings or travel across state lines without following COVID guidelines. Getting a flu shot is especially important this year for two reasons. Having the flu and COVID-19 at the same time is extremely dangerous. From the desk of incoming County Legislator Christian Yunker

As we approach the holiday season, we all reflect back on 2020 and how so many aspects of our world Has changed around us. From the County government perspective, much time and effort has been put Into the 2021 budget process which was certainly a challenge considering all of unknowns as we look towards next year.



Our County Manager, Matt Landers and his team worked closely with his department heads and legislature to come up with a budget that would have to stay under the tax cap. This was a major challenge due to a host of reasons. Department heads were tasked with reducing or holding County support flat while health care costs are rising for the County by 17.5% and the average retirement rate increase will be 16%. All departments also had to deal with the ongoing and projected 20% reimbursement cuts from New York State, while of course maintaining all of the mandated services that we are required to provide. In addition, sales tax revenue has suffered due to the pandemic as well as interest earnings. Fortunately, the County was able maintain the current level of funding for outside agencies as well Genesee Community College.

The County took several measures in 2020 in anticipation of the tight financial situation we would be in by initiating a strategic hiring freeze, furloughing 50 employees and deferring capital projects and asset acquisitions. For 2021 the County's response to the budget challenges was to increase the fund balance usage to the tune of \$2.3 million, eliminate and restructure several positions and reduce the revenue sharing to the Towns and Villages. This decision was not taken lightly. With the limitation of the tax cap, reduced revenue from most sources and reduced reimbursement from New York, it was a necessary step. This however has allowed the County to re-allocate \$1.0 million towards roads and bridges which will directly benefit the Towns and Villages. The County is falling behind in maintaining our bridges as they continue to be downgraded and red flagged. While the amount shared with T/V's was less than originally planned, the County will continue to share total revenue in the greatest amount possible. All said and done through the increase in assessed value while staying under the cap, the County was able to reduce its tax rate from \$10.10 to \$9.80/1000 or 3.06%.

Factors that we will be monitoring closely in 2021 that may have some potential budgetary impacts include; sales tax revenue, a possible federal stimulus, NYS aid reductions, Covid-19 impacts and a hopeful vaccine, effects of bail reform and jail population and the State allowing a possible joint jail with Orleans County.



2021 Hometown Hero Banner Program Guidelines



Purpose - To honor and recognize Bergen, NY servicemen and servicewomen who are serving our county in the United States Armed Forces.

Banner Information — Each banner will be 30" by 60", double-sided photo, vinyl material, and will include the following: photograph of the serviceman/woman, name, and branch of service. Banners will be displayed on poles located on Main Street, Rochester Street, and Buffalo Street beginning Memorial Day weekend through Veterans Day. Banners will be stored by the village and be displayed the following year (2022) not necessarily on the same pole/street locations.

Application Requirements — All servicemen/women **must** have the following qualifications:

- A) current resident of Bergen, NY and/or graduate of Byron-Bergen High School
- B) currently serving our country in one of the U.S. Armed Forces (Army, Air Force, Coast Guard, National Guard, Marines, Navy).

Banner Pricing – Each banner will cost the family/sponsor a total of \$200.00. This price includes the double-sided vinyl banner, hardware for hanging the banner, and banner storage. Banners ordered during the year will be stored until when they will be displayed. Any family can request the return of their banner immediately following Veteran's Day.

Sponsorship — Anyone may become a sponsor of this program by making a personal monetary donation. Individuals and businesses are welcome to sponsor by completing and submitting the Sponsor Form. All donations will be used for expenses beyond the cost of banners and hardware.

Town Highway by Mike Johnson



Please be reminded that during a "normal" snow event, it will take plow trucks 2 ½ to 3 hours to complete one pass on all roads. As such, it is very possible that everyone will encounter less than pleasant driving conditions at times. Late evenings and early mornings, with very light traffic volumes, will receive lower levels of service. Every attempt will be made to maintain open and passable roadways, both for normal and emergency traffic. At times, lanes may narrow and accumulate snow. The Town is responsible for snow and ice removal on all Town and County roadways in Bergen as well as State routes. This winter, as in the past, we will strive to provide the same level of the safest possible roadways at all times, within reason and budget constraints.

Also remember to use caution on snow covered roads. Here are a few safety tips: Slow Down, make safe lane changes, pump your brakes on slick roads, and lastly don't tailgate, especially the plow truck. If you can't see him in his side mirror there is a good chance he can't see you! For a First Aid rule: Carbon Monoxide is called "the silent Killer" if you go off the road keep your exhaust clear of snow.

Two additional reminders: Mailboxes, if damaged by our plows will be repaired or replaced, within Town Board adopted limits, as soon as weather, time permit. PLEASE, when installing or repairing your mailbox, remember that our trucks require a minimum 17 ½ feet from center of the roadway. Also, take into account the excessive force of the exhausted snow as it strikes your mailbox assembly.

Please don't hesitate to call me at 494-1362 if I may be of service. Highway Department hours are 7:00 am – 3:30 pm Monday thru Friday. However, you may leave a message 24 hours a day on our answering machine, and I will return your call as soon as possible. In closing, the entire highway department would like to wish everyone a healthy and happy holiday season, and a safe winter.

FEE SCHEDULE FOR THE TOWN OF BERGEN TRANSFER STATION

EFFECTIVE - July 1, 2018

Individuals will place all household trash (light purple bags), recyclables and/or construction and demolition materials in the respective containers provided and must pick up their own dropped or spilled materials.

No hazardous wastes, empty drum, barrels, aerosol cans, pesticide containers, paint cans, etc. will be accepted.

Items and quantities not specifically mentioned in the following fee schedule will be accepted and priced at the discretion of the Attendant.

Persons not following these rules will not be issued further permits.

WEEKLY HOUSEHOLD GARBAGE AND TRASH

\$5.00 per bag (light purple) which are only available from the Town Clerk during normal business hours.

CONSTRUCTION & DEMOLITION (C & D) MATERIALS AND BULK ITEMS

The Town will make every effort to have a container at the Transfer Site every Saturday, during the summer months, for C & D materials. At the discretion of the Town Officials, the container may be on-site for extended periods.

The following items will be accepted when C & D container is available:

\$40.00 per level COMPACT pickup truck, minivan or station wagon

\$50.00 per level FULL-SIZE pickup, or equivalent sized box trailer or van

\$70.00 for loads that are filled over the top of the standard sides of the truck

NO LARGER QUANTITIES WILL BE ACCEPTED

\$10.00 per item tied and bundled no larger than 3 feet long by 2 feet high and 2 feet wide

\$15.00 per non-stuffed chair (kitchen, dining, etc.)

\$25.00 per stuffed chair, mattress or bed springs

\$35.00 per car load, sofa or equivalent size rolled carpet

TELEVISION SETS \$5

CEE EQUIPMENT - FREE OF CHARGE

All **METALS** will be accepted for recycling at no cost – including CLEAN food cans.

APPLIANCES must have motors removed, but the motors will be accepted separately.

REFRIGERATORS, AIR CONDITIONERS, FREEZERS, DEHUMIDIFIERS, ETC. will be assessed a \$20.00 charge for Freon removal and collection to the person disposing of the unit. The fee will be charged whether or not the freon has been removed. PLEASE! Do not cut the tubing and release the freon into the air! A much better alternative is to insist that the store selling you the new unit takes your old unit when delivering the new one.

TIRES: We accept up to 2 tires per family per week at a cost of \$5.00 per tire up to 15 inch, \$10.00 per small truck tire (16-19 inch) or \$20.00 per large truck tire.

TRANSFER STATION HOURS - SATURDAY 9:00 AM UNTIL 3:00 PM

The Transfer Station is located on Townline Road (Route 262). Bags and Punch cards for C & D items must be purchased at the Town Clerk's office. **THE TRANSFER STATION DOES NOT FOLLOW THE HOLIDAY OFFICE CLOSINGS OF THE TOWN CLERK'S OFFICE.**

Town & County Taxes



For your safety in person tax payments will be limited, to avoid this please use the drop box at the main door or please mail payments to P.O. Box 249, sorry for any inconvenience during these difficult times. Please call the office 494-1121 x21 for more information.

If you pay your own taxes, you will receive your tax bill shortly after January 1, 2021. If you should receive a tax bill that an escrow company or someone else is supposed to pay, please call me right away. Don't put it aside and assume that it will be paid. Also, if you have paid off your mortgage and did not receive a tax bill, you should call me. No matter what the situation is, you are responsible for your taxes and penalties, if it is not paid. If you are leaving town for the winter please leave your "winter" address with me so late fees can be avoided. Credit cards (Visa, MasterCard, Discover and American Express) are accepted for payment with a convenience fee.

Tax payments cannot be received before January 1, 2021 per the County Treasurers office, all payments will be stamped after that date. Taxes are due penalty free by January 31st, all taxes have to be paid to me by March 31st. After **March 31st**, the unpaid taxes are returned to the County Treasurer. If you are going to pay them to the County Treasurer by mail, you will need to call his office in Batavia at 344-2550, ext. 2211 as there will be additional penalties.

Dog License News:



I hate to "hound" you, but if your dog's license renewal is due or past due, please take care of it so we don't have to send you a reminder notice or eventually a court appearance ticket. All dogs, four months of age need to be licensed even those in apartments. Proof of a rabies vaccination and proof of neutering or spaying must be presented at the time of licensing. If you receive an appearance ticket, you will have to pay a fee of \$25.00 plus also pay for your dog's renewal. If there is a problem getting an appointment for a rabies vaccination, etc., please call me. I have an answering machine so you can call anytime day or night.
